c. Accessory Building Size Limitation Amendment-from PC

d. Bid for 12th St. repaving budget amendment

The bid came back for road work and will require an amendment to the budget. Trustee Yearous made a motion to amend the budget by transferring an additional \$117,000 to road construction/repair fund making the total \$357,000, second by Clerk Baker, all in favor motion carried.
