a) PLANNING COMMISSION:

c) SEXTON:

Mr. Holshoe mentioned that both Hicks and Miner cemetery have pitcher well pumps for water. He would like to get these operational. Supervisor Travis will investigate it. Mr. Holshoe also mentioned the large bushes that need to be removed as they have overwhelmed the graves. Clerk Baker pointed out in the ordinance bushes and trees, are not allowed. A flower basket must be in line with the headstone for ease of mowing. No statues, shepherd poles, flowerpots or vases are permitted any and all found will be removed.

d) LIBRARIES-HOPKINS/MARTIN:

J.C. Wheeler has summer reading and many activities that can be found on their website and social media.

e) COUNTY COMMISSIONER:

Commissioner Dugan reported on their May 14, 2026 meeting, The commission tweaked the language for the senior citizen millage ballot proposal. Approved PA 116 for two parcels in Lee township as they don't have zoning. The Human Services Building first floor renovation has been awarded to Bekering Construction that renovated the second floor. There is leftover money from a grant from the State being used. May 28, 2026, meeting the commission supported the sale of Caulkins Dam from Consumer's Energy to Confluence Hydro LLC. More detailed information can be found on the county website.

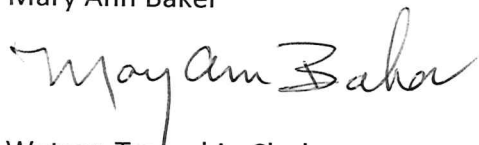
BOARD ROUND TABLE:
